Village of Brady Board of Trustees Regular Meeting May 12, 2021

The Village of Brady Board of Trustee's called to order its regular meeting on Wednesday, May 12, 2021 at 19:02 in the board room of the Brady Community Center. Notice of this meeting was given in advance by posting notices at the following locations: Village of Brady Facebook page, Village of Brady Community Center, Flatwater Bank Brady and Brady USPS office. Said notice stated that the agenda is kept continuously current and available for public inspection at the village office during scheduled office hours. Prior to roll call, vice chairman, Steve Hild, announced the meeting to be an open public meeting and that the current open meeting laws are posted on the wall and available for anyone's review. Board of Trustee members present were Dan Robison, Todd Roe, and Steve Hild. Arlee Gentry and Jeff Miller were absent.

Roe moved to approve the April 14, 2021 regular board meeting minutes. Robison seconded, all aye, motion carried 19:03.

Committee Reports

Streets: Roads have been rocked as per board approval and within budget. Water: Roe reported that all four turbines are going and French drains are installed. Parks: Roe mentioned that the village of Moorfield has asked about hiring Shawn to do their mosquito spraying as well. Treasurer: no report. Maintenance: no report. Clerk report: Axthelm outlined the state statues for publishing official meeting proceedings and explained the difference between official proceedings and meeting notes. It was determined to publish official proceedings with the NP Telegraph hence forth. Axthelm proposed a cooperative effort with the school, businesses, and village next year for our Spring Cleanup. Also discussed was the dedication ceremony for the library funds, the monies received from the Lincoln County Visitor's Bureau grant, the completion of the 2020 Annual Water Quality Report and a clarification on the Pay for Spay program. This program allows for each village member to be reimbursed \$30 for each animal that is spayed or neutered and verified by veterinary receipt, up to 3 animals per year. Law Enforcement: 4 CFS, 44 village hours, to date 277.75 hours. Habitat for Humanity: no report. Community Center Improvements: no report.

Public Comment: Tyler Motsinger requested \$1,500 from Brady Days funds for the fireworks display for this year's Friday night event. This includes a \$300 timer, that will be owned by the village.

Fire Department: Mike Grueber listed activities that the Fire Dept will be sponsoring and participating in for Brady Days. Those activities are: the CPR tent, helicopter landing,

BBQ, guns raffle, meat auction, and partnership with village in setting up, tearing down and running the street dance featuring Whiskey Bent. A committee was formed to create a plan between the fire department and the village for this event. The committee members are: Mike Gruber, Bryan Franzen, Tyler Motsinger, Todd Roe, Steve Hild.

Planning: Brady Johnson reviewed the fee schedule changes for Ordinance 36.01 with board.
